In general, a person who has been infected with COVID-19 requires one less dose of COVID-19 vaccine than others.</li> <li>If your child does not participate in the camp, he/ she is required to go to school.</li> <li>Participants will return home after dismissal on 9<sup>th</sup> December, 2022.</li> <li>In case of adverse weather, the activity will be cancelled. Students should go to school according to the guidelines of the EDB. Students can read the announcement on the webpage of our school that day.</li> </ol>
