**Circular on Payment for Study Tour to South Africa (I)**

Your child has been selected to join the study tour to South Africa (Circular: 25-149/ N03). Our school will organize a Study Tour to South Africa from 9<sup>th</sup> April to 18<sup>th</sup> April, 2026, allowing students to learn about the multiculturalism and natural ecology of South Africa. The itinerary can be found in the attached page for details. Based on current registration, the estimated tour fee is approximately \$31,000 per adult. Part of the tour fee is now being collected from participants to reserve airfare and activity deposits. The details are as follows:

Participants must **pay the latest tour fee by 10<sup>th</sup> March, 2026 (Tuesday) 12:00 noon** to confirm admission. **In case of overdue payment, the school will be unable to collect the fee and participants cannot join the tour.** Once the application is accepted, there is no withdrawal. The paid fee is non-transferable and cannot be converted for other uses. Applicants who quit after payment for any reasons will be treated as withdrawing from this activity. 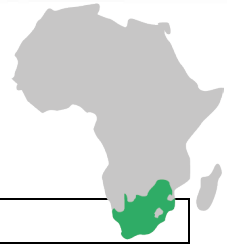



